IN 2015, WE PROVIDED 615,305 MEALS TO 2,907 INDIVIDUALS (UNDUPLICATED), A 30% INCREASE OVER MEALS PROVIDED IN 2014. ON ANY GIVEN MONTH, OVER 545 FAMILIES RECEIVE SUPPORT FROM THE WHITE BEAR AREA EMERGENCY FOOD SHELF. OF THE INDIVIDUALS SERVED, 57% ARE CHILDREN AND 5% ARE SENIORS 65 YEARS OF AGE OR OLDER. IN RECENT YEARS, WE HAVE EXPANDED OUR SERVICES AND STRENGTHENED OUR STRATEGIES TO MEET THE CHANGING NEEDS OF OUR COMMUNITY. IN 2015, WE SURVEYED OUR NEIGHBORS TO DETERMINE THEIR NUTRITION NEEDS, BARRIERS TO HEALTHY FOODS AND IDEAS ON HOW TO IMPROVE THEIR OVER-ALL EXPERIENCE AT THE FOOD SHELF. WE FOUND OUT THAT 96% OF OUR FOOD SHELF FAMILIES ARE INTERESTED IN EATING HEALTHIER, AND 85% OF FAMILIES RECEIVE AT LEAST
