EMERGENCY FUND

A COLLABORATIVE EFFORT BETWEEN LOCAL CHURCHES AND CIVIC GROUPS, THE EMERGENCY FUND IS USED TO HELP FAMILIES WITH SHORT-TERM FINANCIAL SETBACK RELATED TO RENT, UTILITIES, CAR REPAIRS, AND PRESCRIPTIONS. SINCE THE EMERGENCY FUND BEGAN IN 2016, THE WBAEFS HAS ASSISTED 36 FAMILIES WITH EMERGENCY SUPPORT.
