 SINCE 1977, THE WHITE BEAR AREA FOOD SHELF HAS SERVED AS A CRITICAL RESOURCE FOR FAMILIES EXPERIENCING FOOD INSECURITY IN THE WHITE BEAR AREA. WE WORK TO ELIMINATE BARRIERS THAT TRADITIONALLY LIMIT ACCESS TO HEALTHY FOOD FOR FAMILIES LIVING ON A FIXED OR LOW INCOME. THE FOOD AND SUPPORT NEEDS IN OUR COMMUNITY CONTINUE TO GROW EXPONENTIALLY. DUE TO RISING COSTS OF LIVING, IN THE LAST FIVE YEARS WE'VE DOUBLED THE NUMBER OF PEOPLE WE'VE SERVED AT THE WHITE BEAR AREA FOOD SHELF. AND IN JUST A FEW MONTHS THIS YEAR, WE'VE SEEN DEMAND SPIKE 21 PERCENT AS PEOPLE DEAL WITH INFLATION AND REDUCED STATE NUTRITION PROGRAM BENEFITS. OUR NEIGHBORS NEED OUR HELP.
